If no option, then it is understood, someone suggested when the new trainees enter the meeting, current co-hosts hand off responsibility to new people to give them experience and confidence to eventually help us fill 22 meetings a week.

Hosts are supposed to do all they can to be at the business meetings. Please attend. It is timely to do email to all the hosts with every issue so please attend and learn first hand.

Any change in operations MUST be brought to the steering committee for discussion and if warranted then put to a vote for change at the business meeting!! I have brought this up many times and I hate hearing that things changed and I had no idea what the person was talking about. If you just consider this chair as a member who can run a good meeting, well then I will have to reconsider my position. The above is no longer an option and a mandatory operating rule. Not to mention common courtesy.

Going over the allotted time allowed for a share. We have many members who continue to be disrespectful of the attendees and the timer and I would like to see this stop. I have added an option in the new script for hosts to choose 3-4 mins and continuing to go over is selfish. Please, when your time is up, wrap up your share and pass to others. If no hands are up, this is still the case. We have to be consistent in that not one person is better than the others, and give others a chance to share. I have had this complaint from several, new and old timers, and we need to reel in the time. If you are hosting, stop the over users of time. Should Hosts cut the mike at 30 seconds past the time?

Court card verifications. It came to my attention what Elizabeth was instructed to keep track of persons entering late and sending to Khaos who then will not send a court card. This is NOT OK and should be discontinued immediately. This group does not want anyone to keep attendance by Group Conscience and they do not want an email listing sent to our membership. This is violating tradition and not keeping our meetings anonymous. Keep in mind, when people ask for court cards from us, they are giving consent for us to know their identity and email. We do not keep record of these items sent so only the requestor and send are aware.

Please also note, the verification we send state that we cannot confirm or deny that John Doe/Jane Doe was present to I don't see the issue with keeping a log. Zoom is a

new world of AA. In person you can do this by having requests handed in to the host at the start, otherwise, on zoom we should not do this.

I also understand many do not want the court cards regardless and want this to stop. Personally, I am in favor of sending and not in favor of keeping attendance.
